

ARTICLE 1. NAME.

The name of the Corporation is SCOTT R. SLANDA, P. A.

ARTICLE II. DURATION.

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

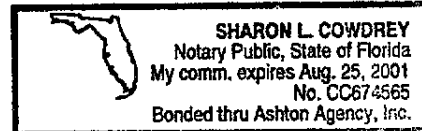
