My client, Global Auto Sales, Inc., has requested that I respond to the enclosed correspondence dated November 1, 1999 from Sean Toner. A copy of that correspondence is enclosed for your convenience, as well as the initial letter sent from my office to the Secretary of State on October 18, 1999 addressing an Application for Reinstatement.

According to the response from Sean Toner, the only circumstance that would allow you to waive fees is if the corporation did not receive the previous annual report notices. While we did not initially address this issue, my client did not receive prior notification concerning filing the annual report. As I previously explained, the corporation became incorporated 12/10/98 and was unaware of the responsibility to file annual reports.
