On behalf of our client, Global Auto Sales, Inc., we are forwarding an Application for Reinstatement and a check in the amount of \$150.00. We ask that this check be accepted in full payment of the annual registration of Global Auto Sales, Inc., due to the fact that the company was incorporated on December 10, 1998, and they had received no prior notice of the annual filing requirements.

In July 1999, we became the accountants for Global Auto Sales, Inc. We were not provided with Articles of Incorporation and, based upon our conversation with our client, were told that they became incorporated in March of 1999 and began in business at that time. To the best of our knowledge, based upon the information they had provided, there was no filing requirement relative to the Annual Report. It was never the intention of the incorporators to willfully disregard nor act negligent in the filing of the Annual Report. Rather, it was their misinformation and inexperience that caused this oversight.

We, therefore, respectfully request that the corporation be reinstated and the payment tendered be accepted in full and final resolution of this matter.

My client, Global Auto Sales, Inc., has requested that I respond to the enclosed correspondence dated November 1, 1999 from Sean Toner. A copy of that correspondence is enclosed for your convenience, as well as the initial letter sent from my office to the Secretary of State on October 18, 1999 addressing an Application for Reinstatement.

According to the response from Sean Toner, the only circumstance that would allow you to waive fees is if the corporation did not receive the previous annual report notices. While we did not initially address this issue, my client did not receive prior notification concerning filing the annual report. As I previously explained, the corporation became incorporated 12/10/98 and was unaware of the responsibility to file annual reports. Had they received notification, they would have filed immediately. However, as you can see on the Application for Reinstatement, the original registered agent was Harvey L. Rubinchik, the attorney who prepared the Articles of Incorporation. Unfortunately, my client did not receive the 1999 Annual Report packet from the office of his attorney, nor was he aware that there would be a filing requirement.

In order to assure that the registered agent will forward all future material to Global Auto Sales, Inc., I have accepted the responsibility as the new registered agent, and have indicated this information in box 9 and box 10 of the Application For Reinstatement.

I would hope that you will acknowledge that there was no intent to disregard filing the annual report, but that the circumstances described above created the confusion concerning filing. Your waiving any additional fees and accepting the enclosed check in the amount of \$150 to effect the reinstatement would be greatly appreciated.

Thank you for your consideration of this matter. I look forward to your prompt response.
