ARTICLES OF INCORPORATION

OF

CENTER FOR ADVANCED COSMETIC DENTISTRY, INC.

KNOW ALL MEN BY THESE PRESENTS: That the undersigned hereby organizes and incorporated for the purpose of forming a body corporate under and by virtue of the laws of the State of Florida, and especially under and by virtue of Chapter 607, CORPORATION LAW, FLORIDA STATUTES, for the transaction of business with and under the following chapter:

ARTICLE I

The name of the corporation shall be CENTER FOR ADVANCED COSMETIC DENTISTRY, INC.

ARTICLE II

The general nature of the business to be transacted by this corporation shall be: To engage in the general business of dentistry, including, but not limited to, investing in the ownership of property, both real and personal, and any other function related thereto; and to perform any other lawful business for which a corporation may be organized under the laws of the state of Florida.

ARTICLE III

The amount of the total authorized capital stock of the corporation shall be seven thousand five hundred (7,500) shares of common stock having a nominal par value of one dollar (\$1.00) per share.

The whole or any part of the capital stock of the corporation shall be payable in lawful money of the United States of America, or property, labor or services at a just valuation to be fixed by the Board of Directors. Property or labor may also be purchased with the capital stock at such valuation as shall be fixed by the directors.

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE V

This corporation is to have perpetual existence, commencing January 1, 1999.

#### ARTICLE VI

The initial address of the principal office, or place of business of this corporation shall be 2990 Business Center Blvd., Melbourne, Florida 32940. The board of directors may from time to time move the principal office of this corporation to any other address in the State of Florida.

#### ARTICLE VII

This corporation shall have one (1) director initially. The number of directors of this corporation shall be increased or diminished from time to time by the By-Laws of the corporation, but shall never be less than one (1).

#### ARTICLE VIII

The name and post office address of the first board of Director, who, subject to the provisions of the Certificate of Incorporation, the By-Laws of this corporation and the laws of the State of Florida, shall hold office until the first meeting of shareholders of said corporation, or until a successor is elected and qualified, shall be:

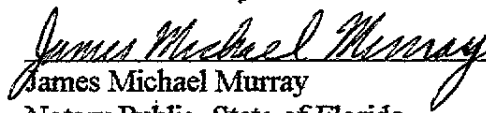

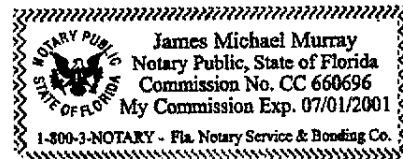
