


On October 17th, one of the principals for Dac-Com Solutions, Inc. was searching through the Corporations Online database and discovered that the company had been dissolved.

After researching the matter I have come up with a timeline of what I believe happened:

- We moved from 1470 NW 107th Avenue Suite N to 2200 NW 102nd Ave Suite 4
- We sent notice to the department for a change of address for Dac-Com Solutions (Owners Roberto Gonzalez and Carlos Castaneda), Dactel Inc (Owner Castaneda) and Com-Pro Systems Inc. (Owner Gonzalez)
- The change of address for Com-Pro Systems Inc. and Dactel Inc. were processed but the one for Dac-Com Solutions was not.
- We received and returned Annual Reports for Com-Pro Systems and Dactel since they were sent to the new address but not for Dac-Com Solutions since it was sent to the old address.
- We did not receive the notice that we had not complied since it too was more than likely sent to the old address.
- We were dissolved

I sincerely ask that you waive the \$600.00 fee for reinstatement and allow our company to continue without the unneeded burden of refiling the Corporation.
