ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Section 607.1003 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is CMILLER ENTERPRISES, INC..

2. The following Amendments to the Articles of Incorporation were adopted by the sole Director and stockholder of the Corporation eligible to vote by the execution of a written statement manifesting his intention that such amendment be adopted, dated the 4th day of October, 1999, in the manner prescribed by Section 607.1003 of the Florida Business Corporation Act:

Article I of the Articles of Incorporation is amended to read as follows:

ARTICLE I

The name of the corporation shall be PLOGUE ENTERPRISES, INC.

Article II of the Articles of Incorporation is amended to read as follows:


ARTICLE II

The principal place for the transaction of the corporation business shall be 1820 Colonial Boulevard, Suite 101, in the City of Fort Myers, County of Lee, in the State of Florida, 33907, and the mailing address shall be the same. That said corporation shall have the right and authority to do business at such other place or places within or without the State of Florida as the corporation may, by resolution, designate.

3. The foregoing Amendments shall become effective and the Articles of Incorporation shall be deemed to be amended thereby upon the filing of these Articles of Amendment by the Department of State.

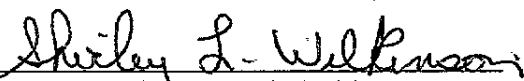
