The name of this corporation is Florida Academy of Aviation, Inc.

Article IV Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

This corporation elects not to be subject to the provisions of Section 607.0901, Florida Statutes, regarding affiliated transactions.


Article XIII - Control-Share Acquisitions
