ARTICLE I

NAME

CAPITAL STOCK

The Corporation shall be authorized to issue Two Thousand (2,000) shares of Common Stock. The shares shall consist of One Thousand (1,000) Class A Voting Common Stock, with a par value of One Dollar (\$1.00) per share, and One Thousand Class B Non-Voting Common Stock, with a par value of One Dollar (\$1.00) per share. Each class of shares shall be identical in all respects, except the Class B Non-Voting Common Stock shall carry no right to vote for any matter presented to the Shareholders.
