


ARTICLE VIII. AMENDMENT

ARTICLE IX. SECTION 1244 ELECTION

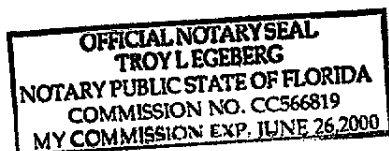
The stock of this Corporation is intended to qualify under the requirements of Section 1244. Such actions as are necessary will be taken by the appropriate officers to accomplish this compliance.




