**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
NATIONAL ASSOCIATION FOR CONTINUING EDUCATION, INC.**

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of **NATIONAL ASSOCIATION FOR CONTINUING EDUCATION, INC.**, a Florida corporation (the "*Corporation*"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is National Association for Continuing Education, Inc.

SECOND: The Articles of Incorporation of the Corporation are hereby amended by deleting Article I thereof as it now exists and inserting in lieu thereof the following new Article I, reading as follows:


"ARTICLE I.

The name of the Corporation is MIIIG Partners, Inc."

THIRD: The effective date is the date these Articles of Amendment are approved by the Florida Secretary of State.

FOURTH: The foregoing amendment was adopted by all of the shareholders and the board of directors of the Corporation on February 21, 2019. The number of votes cast for the amendment by the shareholders was sufficient for approval.
