**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME OF CORPORATION**

The name of this corporation shall be INTRYCK, INC.

**ARTICLE II - GENERAL NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation shall be to conduct and transact any business lawfully authorized and not prohibited by Chapter 607, Florida Statutes, as the same may be amended from time to time.
