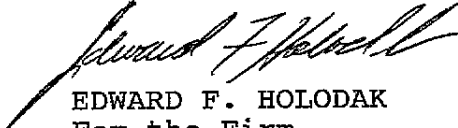

ARTICLE I - NAME AND ADDRESS

The name of this corporation shall be Jennifer Bushey, P.A., with its principal address being 3901 South Ocean Drive, Hollywood, Florida 33019 and mailing address being P.O. Box 2333, Hallendale, Florida 33008.

ARTICLE II - NATURE OF BUSINESS
