THE NAME OF THE CORPORATION SHALL BE:

Budget Investments, Inc.

THE UNDERSIGNED INCORPORATOR, BEING A NATURAL PERSON,

HEREBY FILES THESE ARTICLES OF INCORPORATION UNDER THE
LAWS OF THE STATE OF FLORIDA.

ARTICLE 1
