ARTICLE VI - PRE-EMPTIVE RIGHT

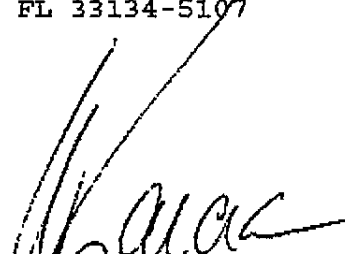

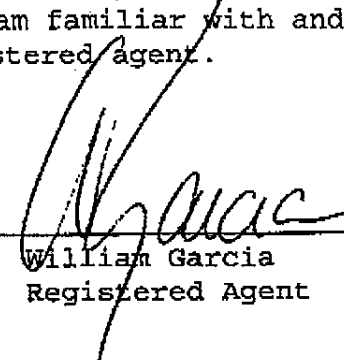
