**ARTICLES OF INCORPORATION
OF**

ARTICLE I - NAME

The name of this corporation is: L. S. Myers MD PA

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of engaging in the practice of medicine as a medical doctor. To engage and render the professional service involved only through its officers, agents, and employees who are medical doctors in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this Corporation. To invest its funds in real estate, stocks, bonds and any other type of investments permitted by law. To own real and personal property necessary for the rendering of the professional services hereby authorized. To engage in no other business other than the rendering of the professional services specified herein.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1000 shares of \$10.00 par value common stock which shall be designated "Common Stock."

ARTICLE V - PREEMPTIVE RIGHTS

Every Shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

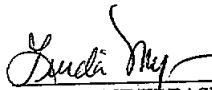
ARTICLE IX - INDEMNIFICATION

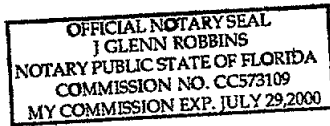
