ARTICLE ONE

The name of the corporation is **BASIX INTERNATIONAL, INC.** The principal address of the corporation is: **823 Dover Street, Boca Raton, Florida 33487.**

The period of its duration is perpetual.

The aggregate number of shares which the corporation shall have authority to issue is 100, at \$1.00 par value.


ARTICLE FIVE
