I, THE UNDERSIGNED, hereby desire to form a corporation, and under the provisions of the statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of this corporation will be RIC CRAIG PRODUCTIONS, INC.

ARTICLE II

The principal place of business and mailing address of this corporation shall be:

ARTICLE III

The general nature of the business and the objectives and purposes to be transacted and carried on are to do any and all things herein mentioned, as fully and to the same extent as a natural person might or could do, viz:

(a) To make and carry out contracts for itself and as managing agent for others of whatever kind and nature and to conduct all business pertinent thereto.

(b) All other purposes for which non-profit corporations may be organized under the laws of this state.

(c) Generally, to make and perform all contracts of any kind and description, and of the purpose of attaining any of the objectives of the corporation, to do and perform any other acts or things, and to exercise any and all powers which a co-partnership or natural person could do or exercise, and which are now or hereafter may be authorized by law, and generally, to do and perform all things necessary or incidental to the performing or carrying out of the powers herein specifically delegated or implied.

#### ARTICLE IV

This corporation shall be authorized one thousand (1000) shares of capital stock, no par value, which said stock shall be voting, and which said stock shall be entitled to any and all dividend payments whatsoever which may be declared and paid by the corporation during its existence.

The foregoing capital stock shall be fully paid nonassessable, and the consideration for all such stock shall be payable in cash, property, labor or services and the valuation of such property, labor or services shall be properly fixed by the Board of Directors at a meeting called by such Board of Directors.

#### ARTICLE V

The street address of the corporation's initial registered office is 4261 S. Small Point, Homosassa Springs, Florida and the name of its initial registered agent at said address is Craig Hoffman.

The corporation shall have perpetual existence.

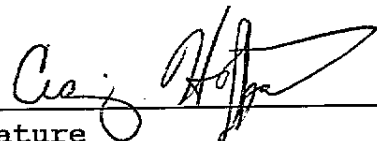
ARTICLE VIII
