ARTICLES OF INCORPORATION OF A SECOND LOOK HOME INSPECTIONS, INC.

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1

The name of the corporation shall be A Second Look Home Inspections, Inc.

ARTICLE 11

The purpose for which the corporation is organized is to engage in the inspection of homes, offices, office complexes, apartments, apartment complexes, cooperatives, condominiums, warehouses, commercial buildings and other such types of real estate to determine the general physical condition.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from engaging in any lawful act or activity for which a corporation may be organized under the General Corporate Law of Florida.


