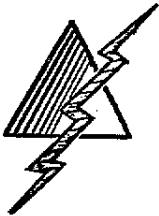

26, 1999 is hereby amended as follows:

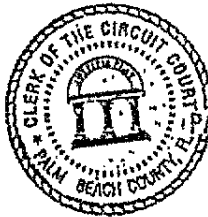
1. The final judgment changes the name of SALVATORE ALASCIA, an adult to
