The undersigned subscriber to these Articles of Incorporation hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

Article I - Name

The name of the corporation is TILLMAN-CLECKLEY, INC. The principal office of the corporation is 1610 Tennessee Avenue, Lynn Haven, Florida 32444 and the mailing address is 1610 Tennessee Avenue, Lynn Haven, Florida 32444.

Article II - Nature of Business

This corporation is organized for the purpose of transacting any or all lawful business.

This corporation shall have perpetual existence and shall commence on the filing of these articles.


