ARTICLES OF INCORPORATION OF YOUR VOICE MANAGEMENT, INC.

The undersigned subscriber to these Articles of Incorporation, a natural personal competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the corporation shall be YOUR VOICE MANAGEMENT, INC.

ARTICLE II NATURE OF BUSINESS

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.
