To Whom It May Concern:

Enclosed please find (finally) the Federal Employer Identification Number for my corporation, Chirohabitat. As the fax received from the IRS on August 6, 2001 indicates, the Federal EIN is 65-1127020.

I have been trying to obtain an EIN for Chirohabitat since May 23, when my original Uniform Business Report, which had been properly filled out by me and sent in on time, was returned to me by your office. Your letter explained that the box for EIN on the prior year's report had stated "applied for" and the current report needed to have an EIN to be considered complete.

I first called the IRS at the Tele-TIN phone #, 770-455-2360, but could not get through. My accountant called an IRS phone # in NY that he was able to get through on, and was told that "the IRS had no record" of my applying for an EIN, even though I had faxed the SS-4 form to the proper fax #, 678-530-6156, the year before. The person he spoke with in NY, a Ms. Smith, explained that she had no way of checking further, but that there was no EIN for Chirohabitat. She suggested that I simply fax the form again, which I did.

The form assured me that I would receive an EIN within a few working days, but I did not. I called the 770 # again, but could not get through. I faxed the SS-4 form again, and waited; again, no EIN was assigned. I called your department and was told that "it was unusual, but keep trying. We haven't heard of anyone else having this problem." I faxed the SS-4 form from a different fax machine, the one in my office, and again received no response. I was not able to get through to the 770 #, despite repeated attempts. The one month you folks were nice enough to give me to resolve the problem of the EIN came and went; still no response from the IRS. I faxed the SS-4 form again, this time with a cover letter explaining my situation and asking them (someone) to call me back and tell me was I doing something wrong? Was there a problem with the way I filled out the form? Why was I having this difficulty when "no one else" was? Still no response.

I called your office in July to express my frustration. I spoke with Stacey at extension 2, corporate reinstatement. She advised me to keep trying, which I did. Finally, after numerous attempts to resolve this problem and obtain an EIN, I received the fax I've enclosed with this.

letter. I am re-submitting my original UBR, this time with the EIN, along with my check for \$150. I know the fee for late filings is \$550, but I also know, from conversations with people in your offices, that exceptions to the late fee are sometimes granted. I must ask for such an exception in that I tried repeatedly to obtain the required EIN through the only two numbers that were available to me, and was, until recently, unsuccessful. I also find it hard to believe that I am the only person who has had this happen, as I faxed the form from several different fax machines. Finally, and not to sound like a jerk, but whoever is reading this letter has had some dealings with the IRS, and if you think you can get through to that 770-455-2360 phone number, please feel free to try. Put it this way: if you do try to get through to that number, and it takes you "X" tries before you succeed, I'll be happy to pay a late fee of \$400-X, because you'll be owing me money!

I do have two corporations here in Florida, and I did file the appropriate UBR for both of them in a timely fashion. I hope that this letter, the completed UBR (with EIN) and my check for \$150 will suffice to bring Chirohabitat into compliance.
