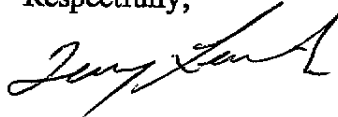

TO THE ARTICLES OF INCORPORATION**

Pursuant to §607.1005, Florida Statutes, where a corporation has not yet issued shares, then a majority of its incorporators or board of directors may adopt one or more amendments to the corporation's Articles. In accordance with that provision, HEAVENLY THREADS, INC. has one incorporator. Additionally, no organizational meeting or stock issuance has occurred. The sole and majority incorporator, James R. McKinley, by his signature below, hereby adopts and files pursuant to §607.1005 and §607.1006, F.S., the following amendments to the Articles of Incorporation:

1. The name of the corporation is Heavenly Threads, Inc.
2. Article VI as filed on December 15, 1998 is hereby deleted in its entirety.
3. The following Article VI of the corporation's Articles of Incorporation is substituted for the former Article VI. This new Article VI shall read as follows:
