**ARTICLES OF INCORPORATION
MEDSOURCE INTERNATIONAL CORPORATION**

Article I

The name of the corporation is:

MEDSOURCE INTERNATIONAL CORPORATION

Article II

The registered office in the State of Florida is to be located at 5728 Major Boulevard, Suite 601, Orlando, Florida 32819. It is located in the County of Orange, Florida.

Article III

The Registered Agent for the Corporation is G. Saddington Stevens, 5728 Major Boulevard, Ste 601, Orlando, Florida 32819. He accepts the responsibilities as outlined in the Florida Statutes.

Article IV

The purpose of this corporation is to engage in any lawful act or activity for which the corporation may be organized under the Laws of the State of Florida.

Article V

The corporation shall have the authority to issue [2] classes of stock immediately. The classification and par value of each of the specific shares of stock shall be as follows:

100,000 Shares of Common Stock with a par value of \$1.00 per share. It is designated as Class A Stock.

100,000 Shares of Preferred Stock with a par value of \$1.00 per share. It is designated as Class B Preferred Stock. Said preferred stock shall be issued from time to time in one or more classes or series with such dividend rates, voting rights, rights of conversion, rights upon dissolution or liquidation, preferences and relative participation, optional or special rights or qualifications, limitations or restrictions thereof, as shall be determined by resolution adopted by the Board of Directors at the time such stock is issued.
