**ARTICLES OF INCORPORATION
OF
GET INSTAFUND TODAY, INC.**

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:


1. The name of the corporation is Get InstaFund Today, Inc.
2. The period of its duration is perpetual.
3. The purpose is to engage in any activities or business permitted under the law of the United States and in Florida.
4. The corporation shall have authority to issue one thousand (1,000) shares, all of one class of common voting stock, no par value per share.
5. The amount of capital with which this corporation shall commence shall be not less than One Thousand Dollars (\$1,000.00).
6. The mailing address of its initial registered office is P.O. BOX 368, MICANOPY, FL 32667. And the street address is 209 SE TUSCAWILLA RD., MICANOPY, FL 32667. The name of its initial agent at said address is Glen W. Gilson, III.
7. The number of directors constituting its initial board of directors is two (2), whose names and addresses are as follows:

Glen W. Gilson, III, 209 SE TUSCAWILLA RD., MICANOPY, FL 32667 and
Paige Thomas, 209 SE TUSCAWILLA RD., MICANOPY, FL 32667.

The directors shall have authority to make binding decisions for the corporation.
8. The name and address of the incorporator are Glen W. Gilson, III, 209 SE TUSCAWILLA RD., MICANOPY, FL 32667.
9. The preemptive rights shall be as follows: The holders of the common stock of this

corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the board of directors, such shares of the stock of this corporation as may be issued for money (money, or any property or services) from time to time, in addition to that stock authorized (and issued) by the corporation. The preemptive right of any holder is determined by ratio of the authorized (authorized and issued) shares of common stock held by the holder to all shares of common stock currently authorized (authorized and issued).


