## ARTICLES OF INCORPORATION OF VALRICO COIN LAUNDRY, INC.

The undersigned incorporator to these Articles of Incorporation ("Articles"), for the purpose of forming a corporation for profit under the Florida Business Corporation Act, hereby makes, subscribes and adopts the following Articles in accordance with the laws of the State of Florida.

#### ARTICLE I NAME

The name of the corporation shall be:

#### ARTICLE II PRINCIPAL OFFICE

The total number of shares of capital stock that this corporation is authorized to be issued by the corporation shall be **ONE-THOUSAND** (1000) **SHARES** of common stock having a par value of \$1.00 per share.
