ARTICLES OF INCORPORATION

#### ROYAL II CORP.

## ARTICLE I - NAME AND ADDRESS

The name of this corporation is ROYAL II CORP. (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 12550 Biscayne Boulevard, Suite 215, North Miami, Florida 33181.
