ARTICLES OF INCORPORATION

OF

CASTLE FOUR CORP.

ARTICLE I - NAME AND ADDRESS

The name of this corporation is CASTLE FOUR CORP. (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 12550 Biscayne Boulevard, Suite 215, North Miami, Florida 33181.

<u>ARTICLE II - PURPOSE</u>
