

ARTICLES OF INCORPORATION OF FERTIKOLA, INC.



The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office and Mailing Address

The name of this corporation is FertiKola, Inc. The corporation's principal office street address is 903 Mooring Circle, Tampa, FL 33602 and mailing address is P.O. Box 2187, Tampa, FL 33601-2187.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on December 15, 1998.
