**CERTIFICATE OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
NICHOLS KLINE GROUP, INC.**

A Florida Corporation

The undersigned hereby certifies as follows:

ONE: That they are the President and Secretary, respectively of Nichols Kline Group, Inc., a Florida Corporation.

TWO: That at a meeting of the Shareholders and the Board of Directors of the Corporation, held on June 19, 2002, the Corporation resolved to amend Article I of its Articles of Incorporation, as follows:

RESOLVED, that the Corporation amend its Articles of Incorporation Article I as follows:

ARTICLE I - NAME

"The name, Nichols Kline Group, Inc. is changed to Comergernt, Inc."

THREE: This amendment was approved by the required vote of shareholders in accordance with the corporation laws of the State of Florida. The total number of outstanding shares of each class entitled to vote for the amendment is forty six million seven hundred thirty thousand (46,730,000) shares. The amendment was approved by a vote of twenty eight million (28,000,000) shares equaling 59% of all shares entitled to vote.
