ARTICLES OF INCORPORATION

The undersigned incorporators of these Articles of Incorporation being natural persons, competent to contract, hereby form a composition ration under the laws of the State of Florida by and under the drown visions of the Statutes of the State providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I - NAME

The name of the corporation is Eddie's Sod Co., Inc. (hereinafter referred to as the "Corporation").

ARTICLE II - PURPOSES OF CORPORATION

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the General Corporation Act of the State of Florida, and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all power conferred from time to time by law upon corporations formed under such Act.

Property or labor may also be purchased with the capital stock at such a valuation as shall be determined by the Directors.

ARTICLE V - INITIAL CAPITAL

The amount of capital with which the corporation shall begin business shall be \$5,000.00.

ARTICLE VI - TERM OF EXISTENCE

The corporation shall have perpetual existence.
