

This corporation shall commence its perpetual existence on the date the Articles of Incorporation are filed with the State of Florida, Department of State.

ARTICLE III

The general purpose for which this corporation is organized is;

To do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the powers enumerated in these Articles of Incorporation or any amendment thereof, necessary of incidental to the protection and benefit of the incorporation, as principal, agent, director, trustee or otherwise, and, in general either alone or in association with other corporations, firms or individuals, to carry on any lawful business necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects of the corporation, whether or not such business is similar in nature to the proposes and objects set forth in these Article of Incorporation or any amendment thereof.
