AMENDMENT TO
ARTICLES OF INCORPORATION OF
FLORIDA MEDICAL TRAINING INSTITUTE, INC.

Pursuant to the provisions of Chapter 607, Florida Statutes, and its Articles of Incorporation, the undersigned corporation adopts the following Amendment to its Articles of Incorporation, as originally filed with the Secretary of State of the State of Florida on December 18, 1998, effective January 1, 1999.

I. The name of the Corporation is FLORIDA MEDICAL TRAINING INSTITUTE, INC.

II. The following amendment to the Articles of Incorporation was adopted by the corporation:

A. Article III is hereby amended by altering it in its entirety so as to read:

"ARTICLE III SHARES

The number of shares of stock that this corporation is authorized to have outstanding at any one (1) time is one hundred thousand (100,000), with a par value of one cent (\$0.01)."

III. The amendment to the Articles of Incorporation was adopted pursuant to section 607.1005, Florida Statutes, wherein the Incorporator may amend the Articles of Incorporation if shares have not yet been issued. The undersigned is the sole incorporator.

IV. The above Amendment does not require shareholder approval, as shares have not yet been issued.

V. The above Amendment was adopted by the Incorporator on the 21ST day of May, 1999.
