The undersigned natural person of the age of twenty-one years or more, for the purpose of forming a corporation under the Florida Business Corporations Act adopts the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is: **Allan K. Horowitz & Associates, Inc.**

ARTICLE TWO

The address of the corporation's principal office as of January 1, 1999 is 900 Winderly Place, Suite 145, Maitland, Florida 32751. The initial registered office in this state is:

**2530 English Ivy Court
Longwood, Florida 32779**

and the name of its initial registered agent as such address is: **Allan K. Horowitz**

ARTICLE THREE

The aggregate number, class and par value, if any, of shares which the corporation shall have authority to issue shall be:

1,000 no par common shares of one class.

The preferences, qualifications, limitations, restrictions, and the special or relative rights, including convertible rights, if any, in respect of the shares of each class are as follows: **None.**

ARTICLE FOUR

The number and class of shares to be issued before the corporation shall commence business, the consideration to be paid therefore and the capital with which the corporation will commence business are as follows:

The number of directors to constitute the board of directors is **one** and the duration of the corporation is perpetual.

ARTICLE SEVEN

The corporation elects to have preemptive rights as provided by law.

ARTICLE EIGHT

The corporation is formed for the following purposes:

1. To operate retail businesses of all types, including an insurance agency and brokerage and in that capacity to buy and sell at wholesale and retail, to hire employees and generally to carry out all other functions and duties permitted by law.
2. To own, hold, build, construct and erect buildings and structures of every type, and to buy, sell, lease, own, manage and maintain same and to buy or otherwise acquire, to own, hold, lease, sell or otherwise dispose of, mortgage or otherwise encumber real property and personal property of all kinds and to maintain same.
3. To indemnify officers, directors, employees and agents as permitted by Florida Statutes §607.0850.
4. To transport, convey and deliver, as a private carrier, all kinds and character of commodities, for the company or for others, and to do all things necessary, convenient or incidental thereto.
5. To borrow money and for such purpose to execute notes, bonds, debentures or any other form of evidence of indebtedness, and to secure the payment of the same by mortgage, deed of trust or other form of encumbrance, pledge or other form of hypothecation.
6. To execute deeds, mortgages, deeds of trust, contracts, guarantees or any other type of written instruments for any corporate purpose.
7. To purchase, acquire, hold, own, sell, assign, transfer or otherwise encumber shares of stock in this company or any other corporation or any bond or debt instrument of this state, or any other state, county, country, government, governmental body, or any interest therein, and while owner thereof, to exercise all rights powers and privileges pertaining thereto.

8. To loan or otherwise invest its funds, from time to time, secured or unsecured, for such time and upon such terms and conditions as its Board of Directors may authorize.

9. To buy, or otherwise acquire, sell, or otherwise dispose of, pledge or otherwise hypothecate stocks, bonds, notes, debentures, accounts receivable and all other types of securities, evidences of indebtedness or choses in action, and to pay compensation for services rendered in connection therewith, and deal in franchises and every type of patent, trademark, service mark and license.

10. To have and exercise all powers necessary or incidental to carrying out its corporate purposes and to possess and exercise all other powers permitted by law.
