The name of this corporation is QUANTUM DIAGNOSTICS, INC., whose principal office and mailing address is 302 Pine Tree Drive, Indialantic, Florida 32903.

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.
