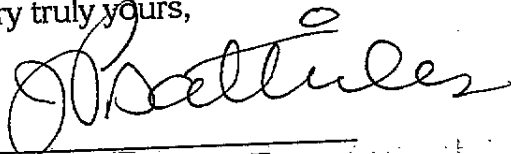

ARTICLE IX. Informal Shareholder Action

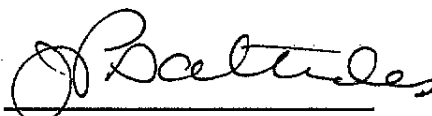

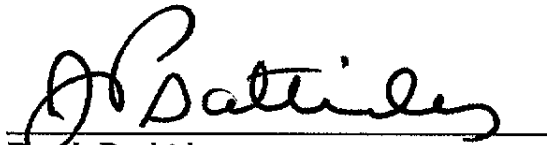
