## ARTICLES OF INCORPORATION

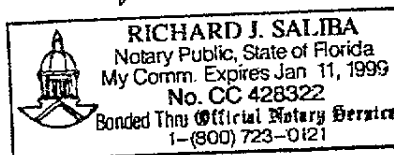
