ARTICLES OF INCORPORATION

OF

PERICLES II HOLDING CORP.



ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Pericles II Holding Corp. Its principal office and mailing address is The Colonnade, Suite 710, 2333 Ponce de Leon Boulevard, Coral Gables, Florida 33134.

ARTICLE II - DURATION

The effective date of this Corporation shall be December 16, 1998, and it shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida, including, but not limited to engage in real estate investment and any other lawful business activities ancillary thereto.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock of no par value, comprised of 500 shares of Class A voting stock, and 500 shares of Class B non-voting stock.
