The undersigned subscriber to the articles of incorporation, BRUNO PASQUALI, who is a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I.

Name

The name of this corporation is B & L RESTAURANTS, INC. The mailing address of the corporation is 4678 Longlake Drive, Sarasota, FL 34231.

ARTICLE II.

Term of Existence

The date when corporate existence shall commence shall be the date of filing of these articles with the Department of State, and the corporation shall have perpetual existence thereafter.

ARTICLE III.

Nature of Business
