ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

Article I - Name

The name of the corporation is FLORIDA ASPHALT PAVING COMPANY. The principal office of the corporation is 1310 Redwood Avenue, Panama City, Florida 32401, and the mailing address is 1310 Redwood Avenue, Panama City, Florida 32401.

Article II - Nature of Business

This corporation is organized for the purpose of paving and construction and the transacting any or all lawful business.

Article III - Duration

This corporation shall have perpetual existence and shall commence on the filing of these articles.

Article IV - Capital Stock

This corporation is authorized to issue 10,000 shares of common stock, each share having the par value of \$1.00.

Article VII - Preemptive Rights


