**ARTICLE I**  
**Name**

The corporate name that satisfies the requirements of Section 607.0401 is: Professional Business Services, Inc.

**ARTICLE II**  
**Principal Address**

**Purpose**

Any repeal or modification of the provisions of this Article VII shall not adversely affect any right or protection hereunder of any person in respect of any act or omission occurring prior to the time of such repeal or modification.

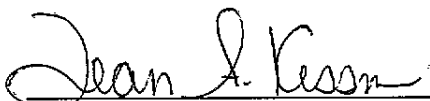
