ARTICLES OF INCORPORATION

The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be Aronson Financial Consultants, Inc. The principal place of business of this corporation shall be 15268 Fiddlesticks Blvd., Fort Myers, FL 33912.

ARTICLE II. NATURE OF BUSINESS


