## ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

#### ARTICLE I

# Name and Business Address

Section 1.1 Name. The name of the corporation is COPPEN'S UNITED HOUSE OF KARATE, INC. The business address of the corporation is PO BOX 1373, Callahan, FL 32011

### ARTICLE II

# **Duration**

Section 2.1. <u>Duration</u>. This corporation shall exist perpetually.
