CERTIFICATE OF INCORPORATION

THE UNDERSIGNED subscriber to these Articles of Incorporation, each a natural person, competent to contract, hereby associates themselves together to form a corporation for profit under the laws of the State of Florida; and further does agree to the following conditions of said corporation:

ARTICLE I: NAME AND PRINCIPAL ADDRESS OF BUSINESS

The name of the corporation is:

ARTICLE II: NATURE OF BUSINESS

The officers of the first Board of Directors shall hold office until the first annual meeting of the Stockholders of the corporation.


ARTICLE VII: AMENDMENTS




