ARTICLE ONE

The name of the corporation is PRECISE BUILDERS, INC.

ARTICLE TWO

The period of its duration is perpetual.





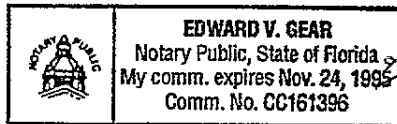
