SOUTHEAST FIBERS, INC.

<u> ARTICLE I - NAME</u>

The name of this corporation is Southeast Fibers, Inc., and its principal place of business and mailing address is 1122 Lakewood Road, Jacksonville, Florida 32207.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the filing of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.
