ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation is WORLDNET CORPORATION (hereinafter salled the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is c/o Paul Siska, 905 Brickell Bay Drive, Suite 928, Miami, Florida 33131.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
