OF

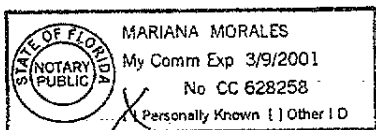


