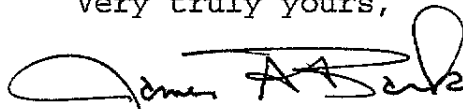

The undersigned Incorporators to these Articles of Incorporation hereby associates himself to form a Corporation under the Laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation is: KC ENTERPRISES OF ORLANDO, INC.

ARTICLE II. COMMENCEMENT AND DURATION

Corporate existence of this Corporation shall commence upon the filing of these Articles of Incorporation by the Department of State of the State of Florida, and this Corporation is to exist perpetually.
