**ARTICLE ONE - NAME**

ARTICLE NINE - INDEMNIFICATION

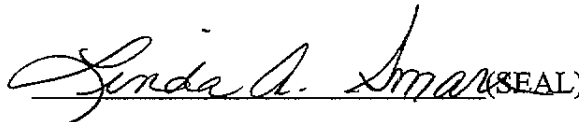

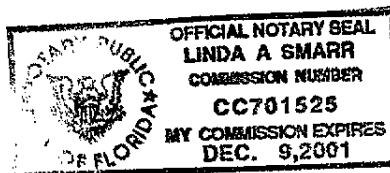
